#### Please take note of the following:

- In order to enroll in ZCCC's preschool academic year, your tuition account must be current.
- A non-refundable enrollment fee of \$75.00 per family is due at the time of enrollment for all new & returning families. An additional deposit is NOT required with enrollment. This fee covers enrollment from August 9, 2022 through the last day of ZCCC's summer 2023 program. This fee holds your spot in the program. This enrollment fee is non-refundable.
- Our academic year is a 42 week commitment (August 9, 2022 ~ May 25, 2023) which consists of 180 school days and built-in inclement weather days. Tuition totals highlighted in yellow show the total amount owed for the academic year.
- There are two payment options:
  1. Pay weekly, each Thursday, for the upcoming week.
  2. Pay biweekly, every other Thursday, for the upcoming two weeks.
- The processing fee for all debit/credit card transactions through Tuition Express is 5% of the total transaction. This fee is in addition to your tuition. You can avoid this weekly fee by putting a checking account on file through Tuition Express.

All program ages are as of September 30, 2022

- ⇒ Tadpoles - 16 months old
- ⇒ Caterpillars & Inchworms- 2 years old
- ⇒ Bumblebees & Honeybees 3 years old
- ⇒ Frogs- 4 years old (Pre-K)
- ⇒ Owls - 5 years old (Kindergarten)

- Families are responsible for the total tuition amount of the program in which they have enrolled their child regardless of absences due to illness, school closure, inclement weather or vacation.
- ZCCC academic year tuition totals take into account holidays, school closures and inclement weather. Make-up days/substitution days are NOT permitted. Additional days must be submitted by the Monday prior to the week you need care and approved by administration. Approval is based on availability and a tuition charge of \$50 will be applied to your Thursday or Friday auto-payment for any additional days.
- ZCCC administration does not send weekly payment reminders or statements. It is the parent/guardian's responsibility to regularly login to [myprocare.com](https://myprocare.com) and check their tuition account.
- Families must provide a 30~day written notice of their intent to terminate ZCCC childcare services. Families will be responsible for payment for 30 days after the notice is given.
- Furthermore, families must provide a 30~day written notice if their enrollment plans change. Payment of the current tuition is required within this 30-day period regardless of whether the child attends.

## COVID-19 Policy & Closure Authority

We are following guidance from the Virginia Department of Social Services, the CDC, and the Virginia Health Department. As of today, the guidance states that we will be doing rigorous cleaning and daily health checks, that will include taking everyone's temperature at the door before they are allowed in the building and checking to make sure not only the child but the whole family is symptom free.

Due to the unprecedented situation of COVID-19, ZCCC reserves the right to refuse entrance to our program if your child shows any signs of illness or symptoms of COVID-19, including but not limited to fever of 100.4 or higher, persistent cough, rash, and any other cold or flu symptoms that have not been treated by a physician, and may be contagious.

If anyone in your household tests positive, your family will need to quarantine for 10 days. Drop off and pick up will be at designated pick-up/drop off doors. If you need to come in the building masks are required for all adults, regardless of vaccination status. Children are not required to wear masks but it is encouraged, especially when socially distancing cannot be maintained. If someone in 1 classroom becomes infected that class will have to quarantine for 10 days or based on the health departments recommendation. In the event of this happening in 1 room we would make sure we are monitoring the rest of the school closely and we would let everyone know there was potential exposure. That classroom would be deep cleaned and disinfected. If it spreads to multiple classrooms, we would all have to quarantine for 10 days and then same rules apply for the sick children.

In the event that the Governor shuts everything down we would obviously have to follow orders. More details and guidance will come through as we get closer, and we will update you as things progress.

ZCCC reserves the right to close down all operations with little or no notice due to COVID-19. In the event that ZCCC is forced to shut down center-wide for any reason longer than five (5) consecutive days a freeze on automatic tuition payments will be put into place.
