Preschool program ages are as of September 30, 2024. Children in our 2's classes must be 2 years old by their first day of school.

Registration:

- Families may sign their children up for 3-5 days each week at the rates above.
- Current family registration opens March 18, 2024. Open registration begins April 1, 2024 and is ongoing until our max enrollment is reached.
- A 10% discount is given to the oldest child if two or more siblings sign-up for 5 days a week enrollment.

Summer Program Billing Information:

- To enroll in ZCCC's summer program, your tuition account must be current, and you must have a valid form of payment on file through Tuition Express.
- A **non-refundable** enrollment fee of \$75.00 per family is due at the time of enrollment for all NEW families. Currently enrolled families do not pay an additional enrollment fee for summer care.
- Our summer camp program is a 10 week commitment (May 28, 2024 August 2, 2024). Program tuition totals and weekly payment amounts are listed on page 1.
- There are two payment options:
 - 1. Pay weekly, each Thursday, for the upcoming week.
 - 2. Pay biweekly, every other Thursday, for the upcoming two weeks.
- The processing fee for all debit/credit card transactions through Tuition Express is 5% of the total transaction. You can avoid this weekly/biweekly fee by having a checking account on file through Tuition Express.
- Families are responsible for the total tuition amount of the program in which they have enrolled their child, regardless of absences due to illness, school closure, inclement weather, or vacations (outside of approved vacation tuition credit during summer programs).
- Each family enrolled will be given a one week vacation tuition credit that can be used only between May 28, 2024 and August 2, 2024. If a vacation is not taken you will not receive the tuition credit. The credit is for a Monday-Friday vacation and cannot be broken up over weeks. Due to billing procedures, we must have two weeks advance notice of your vacation dates for the credit to be given.
- Make-up days/substitution days are not permitted in our program. Additional days may be
 added but your request must be submitted to ZCCC Administration by the Monday prior to
 the week you need care. Approval is based on availability and a charge for any additional days
 will be applied to your Thursday payment.
- Families must provide a 30 Day written notice of their intent to terminate ZCCC childcare services. Families will be responsible for payment 30 days after the notice is given.
- Families must provide a 30 Day written notice if their enrollment plans change. Payment of the current tuition is required within this 30-day period regardless of whether the child attends.
