Daycare/preschool liability agreement

This agreement outlines the responsibilities of Zion Christian Children Center (ZCCC), Zion United Methodist Church (ZUMC), and the parents/guardians of enrolled children. It is intended to ensure the safety, well-being, and proper care of all children while clarifying liability limits.

1. Assumptions of Risk

- Parents/guardians acknowledge that participation in preschool activities, including indoor and outdoor play, field trips, and classroom experiences, carries inherent risk of minor or major injury.
- By enrolling your child, parents/guardians accept these risks and agree that ZCCC will take all responsible precautions to provide a safe environment.

2. Medical Authorization

- In the event of illness or injury, ZCCC staff may administer basic first aid and will contact parents/guardians immediately.
- If emergency medical treatment is required, ZCCC has permission to seek care from qualified medical professionals until parents/guardians can be reached.

3. Liability Limitations

- ZCCC/ZUMC is not liable for injuries or accidents that occur as a result of normal preschool activities, provided staff have acted with reasonable care and within established safety protocols.
- ZCCC/ZUMC is not responsible for lost or damaged personal belongings brought from home.

4. Parent/Guardian Responsibilities

- Parents/Guardians agreed to provide accurate health emergency contact information.
- Parents/Guardians will inform ZCCC of any medical conditions, allergies, or behavioral concerns that may affect their child's participation.
- Parents/Guardians agree to follow all Center policies, including those related to illness, discipline, proper footwear, clothing, and pick up/drop off procedures.

5. Identification:

- Parents/Guardians agreed to indemnify and hold harmless ZCCC/ZUMC, an affiliate, from any claims, damages, or expenses arising from their child's participation, except in cases of gross negligence or willful misconduct by ZCCC staff.
