## **Registration:**

- Families may sign their children up for 5 days each week at the rates shown on the tuition sheet.
- Open registration begins April 1, 2024 and is ongoing until our max enrollment is reached.
- A 10% discount is given to the oldest child if two or more siblings sign-up for 5 days a week enrollment.

## **Academic Year Program Billing Information:**

- To enroll in ZCCC's academic year program, your tuition account must be current, and you must have a valid form of payment on file through Tuition Express.
- A **non-refundable** enrollment fee of \$75.00 per family is due at the time of enrollment for all new and returning families. An additional deposit is not required with enrollment. This fee covers enrollment from August 8, 2024 through the last day of ZCCC's 2025 summer program. This fee holds your spot in the program.
- Our academic year program is a 42 week commitment (August 8, 2024 - May 22, 2025). Program tuition totals and weekly payment amounts are listed on page 1.
- There are two payment options:
  1. Pay weekly, each Thursday, for the upcoming week.
  2. Pay biweekly, every other Thursday, for the upcoming two weeks.
- The processing fee for all debit/credit card transactions through Tuition Express is 5% of the total transaction. You can avoid this weekly/biweekly fee by having a checking account on file through Tuition Express.
- Families are responsible for the total tuition amount of the program in which they have enrolled their child, regardless of absences due to illness, school closure, inclement weather, or vacations. ZCCC academic year tuition totals take into account holidays, school closures and inclement weather days.
- Make-up days/substitution days are not permitted in our program. Additional days may be added but your request must be submitted to ZCCC Administration by the Monday prior to the week you need care. Approval is based on availability and a charge for any additional days will be applied to your Thursday payment.

## **Academic Year Program Billing Information (continued):**

- Families must provide a 30 Day written notice of their intent to terminate ZCCC childcare services. Families will be responsible for payment 30 days after the notice is given.
- Families must provide a 30 Day written notice if their enrollment plans change. Payment of the current tuition is required within this 30-day period regardless of whether the child attends.

## **After School and Kids Days Off Additional Information:**

- The week of Spring Break and the week of Christmas break have been factored into our After School Program Academic year tuition total .
- Enrollment in our Kids Day Off program is a commitment for all Kids Day Off days offered in the 2024-2025 Academic Year period. You may cancel any Kids Day Off dates that you do not need care, up to one week prior to that date to avoid being charged for those dates. There are 17 days in the upcoming academic year (August 8, 2024-May 22, 2025) that we will have Kids Day Off care. Those dates are subject to change according to the Louisa County Public School Calendar or election days.
