Elementary Program is open to children K through 5th grade (5 - 12 Years old). Preschool program ages are as of September 30, 2026. Children in our 2's classes must be 2 years old by their first day of school.

Registration:

- Current family registration opens March 17, 2026. Open registration begins April 1, 2026 and is ongoing until our max enrollment is reached.
- A 10% discount is given to the oldest child if two or more siblings sign-up for 5 days a week enrollment. To qualify for the 10% ZUMC Member Discount, your family must have at least 6 months of active involvement in the church.

Summer Program Billing Information:

- To enroll in ZCCC's summer program, your tuition account must be current, and you must have a valid form of payment on file through BrightWheel
- A **non-refundable** enrollment fee of \$75.00 per family is due at the time of enrollment for all families.
- Our summer camp program is a 10 week commitment (May 26, 2026 - July 31, 2026). Program tuition totals and weekly payment mounts are listed on page 1.
Payment options: 1. Pay weekly, each Thursday, for the upcoming week.
- The processing fee for all debit/ credit card transactions through BrightWheel is 2.43% of the total transaction. You can avoid this weekly fee by having a checking account on file through Tuition Express.
- Families are responsible for the total tuition amount of the program in which they have enrolled their child, regardless of absences due to illness, school closure, inclement weather, or vacations.
- Make-up days/substitution days are not permitted in our elementary summer care program. Additional days may be added but your request must be submitted to ZCCC Administration by the Monday prior to the week you need care. Approval is based on availability and a charge for any additional days will be applied to your Thursday payment.
- **Families must provide a 30 Day written notice of their intent to terminate ZCCC childcare services. Families will be responsible for payment 30 days after the notice is given.**
- **Families must provide a 30 Day written notice if their enrollment plans change. Payment of the current tuition is required within this 30-day period regardless of whether the child attends.**

Holding Fee – Two-Year-Old Program

A \$270 non-refundable holding fee is required to reserve a space in the 2-year-old classroom. This fee will be applied to the first week's tuition upon the child's start of care.

In addition, a weekly holding fee of 90 will be charged for each week the space is held prior to the child's start date weekly holding fees are non-refundable and must be paid according to the center's billing schedule.

If a child does not begin care on agreed upon start date the center reserves the right to release the reserved space.
