Registration:

- ⇒ Families may sign up their children for 1 - 5 days each week at the rates above.
- ⇒ Sign-up is online through myprocare.com and must be done the Wednesday before the week of attendance for KDO and at time of initial registration for after-school.
- ⇒ Registration begins Monday, April 3, 2023 and is ongoing until our max enrollment is reached.
- ⇒ A 10% discount is given to the oldest child if two or more siblings sign-up for all 5 days of the week.

After-School Billing:

- ⇒ In order to enroll in ZCCC's after-school academic year, your tuition account must be current and you must have a valid form of payment on file through Tuition Express.
- ⇒ A non-refundable enrollment fee of \$75.00 per family is due at the time of enrollment for all new & returning families. An additional deposit is NOT required with enrollment. This fee covers enrollment from August 9, 2023 through the last day of ZCCC's summer 2024 program. This fee holds your spot in the program. This enrollment fee is non-refundable.
- ⇒ Our academic after-school year is a 42 week commitment (August 9, 2023 ~ May 24, 2024) which consists of 195 school days and built-in inclement weather days. Tuition totals highlighted in yellow show the total amount owed for the academic after-school year.
- ⇒ There are two payment options:
 1. Pay weekly, each Thursday, for the upcoming week.
 2. Pay biweekly, every other Thursday, for the upcoming two weeks.
- ⇒ The processing fee for all debit/credit card transactions through Tuition Express is 5% of the total transaction. This fee is in addition to your tuition. You can avoid this weekly fee by putting a checking account on file through Tuition Express.
- ⇒ Families are responsible for the total tuition amount of the program in which they have enrolled their child regardless of absences due to illness, school closure, inclement weather or vacation..
- ⇒ ZCCC academic after school year tuition totals take into account holidays, school closures and inclement weather. Make-up days/substitution days are NOT permitted. Additional days must be submitted by the Monday prior to the week you need care and approved by administration. Approval is based on availability and an additional day of tuition will be applied to your Thursday or Friday auto-payment for any additional days.
- ⇒ ZCCC administration does not send weekly payment reminders or statements. It is the parent/guardian's responsibility to regularly login to myprocare.com and check their tuition account.
- ⇒ Families must provide a 30~day written notice of their intent to terminate ZCCC childcare services. Families will be responsible for payment for 30 days after the notice is given.
- ⇒ Furthermore, families must provide a 30~day written notice if their enrollment plans change. Payment of the current tuition is required within this 30-day period regardless of whether the child attends.

Kids Day Off:

- ⇒ **Advanced sign-up is required for these days.** You must sign up by the Wednesday before the week begins.
- ⇒ These days are highlighted in blue on our academic year calendar.
- ⇒ There is designated electronic time each day for the elementary kids. They may bring an iPad or electronic device.

Kids Day Off continued:

- ⇒ Please provide two healthy snacks, a lunch and a water bottle for each child.
- ⇒ We will take outside breaks, have playground time, and scheduled down-time each day.
- ⇒ ZCCC Kids Day Off families can pay tuition weekly (each Thursday) through Tuition Express auto-pay.
- ⇒ Tuition is billed for the completed week the following Thursday for Elementary Kids Day Off.
- ⇒ In order to sign your child up for Elementary Kids Day Off at ZCCC, your tuition account must be current and you must have a valid form of payment on file through Tuition Express.
- ⇒ Additional days needed must be requested by 6pm on Wednesday prior to the week of attendance & approved by Amy Hall or Cindy Crummette.
- ⇒ If ZCCC is closed due to inclement weather on a Kids Day Off, all children scheduled to attend will not be charged for the Kids Day Off.
- ⇒ If MNES is closed due to inclement weather and ZCCC is open, children scheduled to attend after-school that afternoon but instead attend ZCCC for the day, will NOT be double charged.
- ⇒ **Families must provide a 30-day written notice of their intent to terminate ZCCC childcare services. Families will be responsible for payment for 30 days after the notice is given.**

COVID-19 Policy & Closure Authority:

- ⇒ We are following guidance from the Virginia Department of Social Services, the CDC, and the Virginia Health Department for cleaning and sanitizing, as well as quarantine/isolation and masking.
- ⇒ Due to the unprecedented situation of COVID-19, ZCCC reserves the right to refuse entrance to our program if your child shows any signs of illness or symptoms of COVID-19, including but not limited to fever of 100.4 or higher, persistent cough, rash, and any other cold or flu symptoms that have not been treated by a physician, and may be contagious.
- ⇒ In the event that the Governor shuts everything down we would have to follow orders. More details and guidance will come through as we get closer, and we will update you as things progress.
- ⇒ ZCCC reserves the right to close down all operations with little or no notice due to COVID-19. In the event that ZCCC is forced to shut down center-wide for any reason longer than five (5) consecutive days a freeze on automatic tuition payments will be put into place.
